
**(1) Reservation of Posts**

- Persons with Benchmark Disability (PwBD) Reservation as per Rules.

- If necessary, an elimination test will be arranged.
- Eligible candidates shall be communicated for the further process via email.

3. Scanned copies of Candidate's all necessary copies of testimonials, certificates and documents in PDF format (the digital size of the PDF file should be less than 500 KB).


**STEPS TO BE FOLLOWED FOR FILLING THE ONLINE APPLICATION**
